ULTRA ZINC can be applied as a soil treatment to increase your soil zinc levels, or as a foliar treatment to quickly improve the zinc levels in your crop. It is also widely applied as a seed coat for cereals, which will greatly increase root development after seed emergence.

Pomme/Stone fruit	0.75-1.5	Apply from early season & post harvest or as required
Vines	0.25-0.5	Apply early season & fruit set or as required
Citrus	1.0-2.0	Apply at spring flush & autumn flush
BROADACRE		Minimum Water Rate L/ha: 30-100
Cereals	0.5-1.0	Apply at 3-4 leaf stage, repeat as required
Cotton	0.5-1.0	Apply at 4-6 leaf stage, repeat as required
Corn/Sorghum	0.25-0.75	Apply at 3-4 leaf stage, repeat as required
PASTURE	0.5-1.0	Apply at spring break and when soil Zinc levels are low
SEED COATING		Application Rate = Per Ton of Seed
Cereals	1.5-2.5	Mix with sufficient water to ensure adequate coating of seed
Cotton		
SOIL TREATMENT	2.5-5.0	Apply pre planting or pre season

Application/Mixing: **ULTRA ZINC** can be applied via boom spray, drip irrigation, over head irrigation or aerial. **ULTRA ZINC** should be diluted and applied with a minimum of 30 litres of water per hectare. If mixing with Ag Chemicals a compatibility test should be conducted first.
