eco-shield[®] organic* snail & slug killer is effective at low temperatures, as it does not depend on dehydration for its rapid action. Dead snails will rarely be seen in the open under normal conditions of use, as they usually crawl back to their shelters where they die. Animals and birds may find this bait attractive. This product is mildly acidic and DOES NOT CONTAIN SCHEDULED POISONS such as Metaldehyde or Methiocarb.

This product is designed only for the purpose indicated on the label. Failure to use as directed may be illegal. Use strictly as directed. The vendor may not be liable for loss or damage arising from failure to follow the directions for use.

DO NOT allow animals to feed on a treated area for at least 3 days after application, to allow molluscs to consume bait.

DO NOT place in heaps. Clean up spilled pellets after filling application equipment.

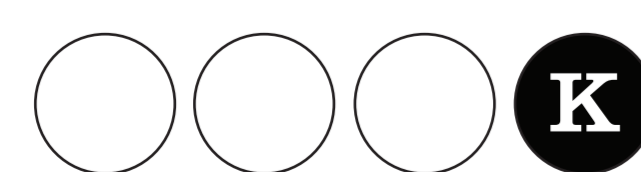
